month, then year and add a comma.

Structure of an MLA 8 citation for a newspaper article found on a database: Author's Last name, First name. "Title of the article." Title of the newspaper, First name Last name of any other contributors, Version (if applicable), Numbers (if applicable), Publication date, Location (generally page numbers, if available).

The Washington Post, pp. A1, A4. Precede page numbers for newspaper articles with p. or pp. If an article appears on discontinuous pages, give all page numbers, and separate the numbers with a comma (e.g., pp. B1, B3, B5-B7).
