If more than one copy of a requested document exists, this request includes a request for production of all non-identical copies. The terms "you" or "your" include the person to whom these requests are addressed, and all of that person's agents, representatives, or attorneys.

With respect to document requests, you should request all documents concerning: (1) the plaintiff; and (2) the decision-making process. Seek all versions, drafts, and copies of the requested documents that differ in any way from the requested documents.
